Sub:- Constitution of Transfer & Posting Board for implementation of Supreme Court Judgment dated 31-10-2013 in WP(Civil) No.82/2011.

Pursuant to Hqrs. office circular No.1 - Staff Wing/2014 No.10-Staff(App-II) 63-2013 dated 06-01-2014 regarding implementation of Supreme Court's Judgment dated 31-10-2013 passed in WP(Civil) No.82/2011 in the matter of Shri T S R Subramaniam and others Vs. Union of India and others, the Competent Authority has decided to constitute Transfer & Posting Board(T&P) to make recommendations for transfer and posting at various levels.

Accordingly, structure of the T&P Board will be as follows:

3. For Group "B" Gazetted Officers.
 - (a) Sr.DAG/DAG(Admn.)
 - (b) Sr.DAG/DAG(W&F)
 - (c) Sr.AO/AO(Admn.)
 - Senior amongst the two Group Officers would be the Chairperson of the Board.
 - Head of the Department would be the Accepting Authority.

4. For Group "B"(Non- Gazetted) and Group "C" Officials.
 - (a) Sr.AO/AO(Admn.)
 - (b) Sr.AO/AO(Book)
 - (c) Sr.AO/AO(I/c Pen.I)
 - Senior most Branch Officer would be the Chairperson of the Board.
 - Group Officer in-charge of Administration would be the Accepting Authority.

3. The Transfer & Posting Board as notified above would be the recommendatory body and their recommendations will be placed before the Competent/Accepting Authority for final orders. The Transfer & Posting Board will make recommendations in accordance with the transfer policy notified from time to time.

4. It has also been decided to keep minimum tenure of two years for Group B & C staff and they shall not be transferred from a particular post before the lapse of a minimum period of two years. Transfer of any officer before the completion of the minimum tenure may be done, in public interest, but the reasons for the same will be considered and recorded by the concerned Placement Board, as the case may be, before making their recommendations.
